INDICTMENT

CHARGING VIOLATIONS OF:

COUNT 1: CONSPIRACY, a Class 6 Felony, in violation of A.R.S. § 13-1003

COUNT 2: BALLOT ABUSE, a Class 6 Felony, in violation of A.R.S. §16-1005(H)

The 91st Arizona State Grand Jury accuses **GLORIA LOPEZ TORRES**, charging on this 3rd day of October, 2022, that in or from Yuma County, Arizona:

<u>COUNT 1</u> CONSPIRACY

During a period of time beginning on or about July 12, 2020, and ending on or about August 4, 2020, GLORIA LOPEZ TORRES, with the intent to aid the

commission of an offense, did agree with one or more persons that at least one of them would engage in conduct constituting the offense and one of the parties committed an overt act in furtherance of the offense, in violation of A.R.S. §§ 13-1003, 16-1005(H), 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

Said conduct occurred when **GLORIA LOPEZ TORRES**, with the intent to aid the commission of an offense, did agree with one or more persons that at least one of them would engage in conduct constituting the offense and one of the parties committed an overt act in furtherance of the offense, namely **BALLOT ABUSE**, by conspiring to obtain the ballots of individuals for the Primary Election held on August 4, 2020.

<u>COUNT 2</u> BALLOT ABUSE

During a period of time beginning on or about July 12, 2020, and ending on or about August 4, 2020, **GLORIA LOPEZ TORRES** knowingly collected voted or unvoted early ballots from another person, in violation of A.R.S. §§ 16-1005(H), 16-1005(I), 16-1021, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

Said conduct occurred when **GLORIA LOPEZ TORRES** collected seven early ballots from Nadia Guadalupe Lizarraga-Mayorquin a/k/a Nadia Buchanan for the August 2020 Primary Election.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Yuma County, Arizona.
